The ePayment Center is replacing RedCard as the electronic payment vendor for SIHO. Registration for the ePayment Center is now available, with payments transitioning no sooner than November 15th, 2022. Please follow the instructions below to begin the registration process. If you do not sign up, you will receive mailed payment checks.

- Federal tax identification number (TIN) or employer identification number (EIN)
- Your practice's corporate name and principal information
- Bank account routing transit number (RTN) or ABA routing number

### How do I register for ePayment Center?
